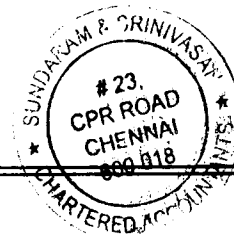
On the basis of the audit as indicated above, we report as follows:-
